Total filings were down by nearly 50 percent during the third week of February compared to the same week last year.² Once again, the largest decline involved chapter 13 filings, which were down by slightly over 63 percent from last year.


The winter storm that hit the Southern and Eastern states last week probably was a factor behind the relatively low filings during the week. Only 139 bankruptcy cases were filed in the State of Texas last week, down by 72 percent from the previous year. Filings in Oklahoma were also down about 72 percent during the week.

The following charts show filing trends by chapter since the beginning of 2020.






Bankruptcy Filing Trends (All Chapters) Percent Change From One Year Prior














Chapter 11 Cases

Chapter 11 case filings were fairly low during the week, down by more than 40 percent from the same week last year.

The single notable filing during the week was by Country Fresh Holding Company Inc., which filed in the Southern District of Texas along with 17 affiliates on February 15. Country Fresh is a supplier of fresh-cut fruits and vegetables and ready-to-go meals.

The 39 subchapter V cases filed during the week represented the highest weekly total in nearly three months. In the first year that subchapter V was available (year ending February 18, 2021), 1,537 such cases were filed.

Disappearing Chapter 13 Cases

The pandemic has brought about a large drop in bankruptcy filings (except for chapter 11 cases). While chapter 7 filings have fallen by 27.5 percent since last April, chapter 13 filings are down by 58.4 percent. In six Northeastern states and the District of Columbia, chapter 13 filings have been down by more than 70 percent over the last 10 months. In the Eastern District of New York, chapter 13 filings have dropped by 93.7 percent.

The peak year for chapter 13 filings was 2003, when filings averaged about 9,000 per week. Even as recently as 2019, chapter 13 filings averaged about 5,500 per week. During the pandemic, chapter 13 filings have fluctuated between 2,000 and 2,500 most weeks.


Chapter 13 filings are likely to remain quite low for at least four more months, as the Biden Administration has recently extended the federal moratorium on foreclosures until June 30.
