
For the fifth consecutive week, less than 6,000 bankruptcy cases were filed nationwide. Prior to this streak, weekly filings had been under 6,000 only five other weeks since the onset of the pandemic. Filings of both chapter 7 and chapter 13 cases are down by about one-half from two years ago (pre-pandemic).












### Chapter 11 Filing Trends Percent Change From 2021 and 2020





#### **Chapter 11 Cases**

Chapter 11 filings during the week were well under the number filed during the same week last year and just a small fraction of the number filed in 2020. (However, the 2020 filing total was skewed by the McDermott International case, which included 224 related filings.)


Additionally, there were no particularly large or notable chapter 11 cases filed during the week.


#### **Monthly Filing Trends During the Pandemic**

Bankruptcy filings have been extremely low since the onset of the pandemic, with monthly filings now running at about half of pre-pandemic levels. As the following charts show, the patterns have varied by chapter. Chapter 7 filings dropped about 30 percent from April through December 2020 and continued to decline even further in 2021. Chapter 13 filings fell 60 percent at the beginning of the pandemic, but the monthly declines were slightly lower by the end of 2021. Chapter 11 filings actually increased throughout 2020, mainly as a result of an unusually high number of very large chapter 11 cases that included multiple related filings. However, chapter 11 filings were down sharply in 2021 compared to pre-pandemic levels.

# Bankruptcy Filing Trends By Month - All Chapters (Percent Change From Same Month in 2019)




## Chapter 7 Filing Trends By Month (Percent Change From Same Month in 2019)
