## Weekly Bankruptcy Analysis January 25 – 31, 2021

Total filings were down by 34 percent during the week ending January 31 compared to the same week last year.<sup>2</sup> Despite the decline, this was the highest weekly total for filings since the last week of October 2020.




The large increase in chapter 11 filings during the week was a result of the filing by workspace provider Knotel, Inc., which filed in Delaware on January 31 along with 213 related entities.




The following charts show filing trends by chapter since the beginning of 2020. Filings dropped sharply around the middle of March 2020 due to the pandemic.






# Chapter 11 Filing Trends (Percent Change From One Year Prior)







#### **Chapter 11 Cases**

Chapter 11 filings were up sharply during the week, but more than 80 percent of the filings were actually related filings by subsidiaries within a corporate group. Excluding related filings, chapter 11 cases would have been down by nearly one-half from the same week last year.

The 24 subchapter V cases filed during the week brings the total to 1,451 of these cases since it became available on February 19, 2020.

#### **Notable Case Filings:**

The pandemic has led to a dramatic increase in prominent bankruptcy filings (*e.g.*, companies with debts and assets of several hundred million or more or firms that are household names), particularly by retailers and energy companies. However, the volume of these larger cases has dropped off considerably in recent months. Last week this trend was reversed as shown by the following five prominent filings during the week.




**Total filings** were down by nearly 30 percent for the year and were only about one-third as high as they were in 2010.






**Filings Relative to Population** dipped to under two cases per 1,000 population for the first time in decades.

### Bankruptcy Filings per 1,000 Population Calendar Years 2000 - 2020




Chapter 7 case filings were down by 21.2 percent from 2019 due to the pandemic.


## Chapter 7 Cases Filed Nationwide Calendar Years 2000 -2020





**Chapter 11** filings were above 8,000 for the first time since 2013 but were still only about one-half as high as they were during the Great Recession.




**Chapter 13** filings were down by over 45 percent from the prior year and were only about one-third as high as in 2003, the peak year for chapter 13. As a result, the proportion of cases filed as chapter 13 was under 30 percent for the first time since 2011.








**Filings by Quarter** were down by nearly 40 percent for the last three quarters of the year as a result of the pandemic.




During 2020 the filing declines were generally more pronounced in the Eastern United States (see states colored red and blue).

Delaware was the only state to report an increase in filings during the year, due to the high volume of chapter 11 cases (and related filings) filed there.



Filings in 2020 were down nearly two-thirds compared to filings in 2010. During that time the largest declines were generally in New England and on the West Coast (see states colored red).
