


Bankruptcy filings continue to decline from prior years. During the week ended June 26, total filings were down 12.5 percent from the same week last year and were down by 30.5 percent from 2020 (early in the pandemic). Additionally, filings last week were less than half the number filed during the same week in 2019 (pre-pandemic).




The following charts show recent weekly filing trends by chapter compared to 2021, 2020 and 2019.

Chapter 11 Cases

The 72 chapter 11 cases filed last week were well below the total filed during each of the last three years. The 18 subchapter V cases filed during the week brings the total filed to more than 3,500 since it became available in February 2020.

There were two notable filings during the week. On June 22, industrial baker Gold Standard Baking, LLC filed in Delaware along with two related entities. Mattress manufacturer Corsicana Bedding, LLC filed in the Northern District of Texas on June 25 along with 11 subsidiaries.

Compensation of Chapter 7 Trustees

Pursuant to the Bankruptcy Improvement Act of 2020, chapter 7 trustees will soon be receiving an extra \$60 payment per case. Prior to the new payment, there were three ways that trustees received compensation: \$60 per case from the filing fee, from the percentage fee on assets administered, and for professional fees and expenses in asset cases.

The Executive Office for U.S. Trustees (EOUST) posts detailed data on fees paid to trustees in the districts covered by the U.S Trustee Program. Comparable data is not available for chapter 7 cases in North Carolina and Alabama, which are under the Bankruptcy Administrator Program.

During 2020, chapter 7 trustees received about \$240 million in total compensation. This includes about \$21.0 million from filing fees (this figure includes a \$1 million adjustment for fees not paid in *in forma pauperis* cases), \$128.1 million in fees for the administration of assets, \$80.3 in attorney fees paid to the trustee or firm, and \$10.9 million in other fees and expenses paid in asset cases.

The new \$60 payment would have given the trustees an additional \$22 million for their work in cases filed during 2020. Although the extra \$60 per case is long overdue, it represents a less than 10 percent increase in total chapter 7 trustee compensation.
