## Weekly Bankruptcy Analysis September 27 - October 3, 2021

Bankruptcy filings were higher than normal during the week because of the spike in filings that occurs at the end of every month. However, chapter 7 filings were down 30 percent from the same week in 2020, and total filings were only about half as high as during the same week two years ago (pre-pandemic).







## **Chapter 11 Cases**

For the second straight week, there were no particularly large or notable cases filed. During the same two-week period last year, there were seven notable chapter 11 case filings, including four energy companies (FTS International, Oasis Petroleum, Lonestar Resources and Bouchard Transportation), two Catholic dioceses (Camden, N.J., and Rockville Centre, N.Y.), and auto parts manufacturer Garrett Motion.

## **Attorneys Who Handle Small Business Chapter 11 Cases**

The Small Business Reorganization Act of 2019 (SBRA) took effect on Feb. 19, 2020. It created subchapter V, a streamlined path through chapter 11 for small business debtors. Between its effective date and Sept. 28, 2021, there were 3,097 small business chapter 11 cases filed

nationwide. In about 80 percent of these cases (2,473 out of 3,097), the debtor chose to proceed under subchapter V.

A little under 4 percent of the cases were filed *pro se*, and in more than half of these cases, the debtor did not choose to proceed under subchapter V. More than 80 percent of the debtors with attorneys chose to utilize subchapter V. More than 1,400 attorneys were listed as the lead attorney in at least one small business case, including about 1,200 who now have handled at least one subchapter V case.

Since subchapter V became available, 119 attorneys have filed five or more small business chapter 11 cases, including 71 who used subchapter V in all cases, and five who never used it. Of the 43 attorneys who had a mix of cases, three filed an equal number of both types, 11 did not use subchapter V in a majority of their cases, and 29 used it in most of their cases.

Overall, the data shows that subchapter V has gained wide acceptance among the bankruptcy bar, and that there are a minority of attorneys who use it infrequently or not at all.
