The 12,507 bankruptcy cases filed last week were the highest weekly total in four years. Three factors contributed to the high weekly filings. First, filings have been on the increase for over one year, after falling precipitously as a result of the pandemic. Second, filings are always higher in March and April than at any other time during the year. Finally, filings always spike on the last business day of the month due to the chapter 7 means test.






Bankruptcy Filing Trends (All Chapters) Percent Change From 2023, 2022, 2021 and 2020






Chapter 7 Filing Trends Percent Change From 2023, 2022, 2021 and 2020





Chapter 11 Cases

The 352 chapter 11 cases filed last week were about triple the normal weekly volume. However, 243 of these cases were filings related to the case filed by Amazon third-party seller Thrashio Holdings Inc., which filed in New Jersey on Feb 28.






Total Bankruptcy Cases Filed in New York Calendar Years 2000 - 2023




Total Filings Relative to Population 2000 - 2023





Bankruptcy Filings per 1,000 Population New York vs. National Average 2000 - 2023

















Chapter 11 Cases Filed in New York* 2000 - 2023




Chapter 13 Cases Filed in New York 2000 - 2023





Percent of Cases Filed as Chapter 13 Calendar Years 2000 - 2023









Filing Trends By Quarter New York vs. National Average (Percent Change From Same Quarter One Year Prior)




Bankruptcy Filing Trends Calendar Year 2023 vs. 2022
