
The 9,845 bankruptcy cases filed last week were above the number of filings during the same week each of the last three years. In fact, it was the highest number of filings in four years for a week that did not include the last business day of the month. (Filings spike at the end of each month due to the chapter 7 means test.)

The effects of the pandemic on bankruptcy filings first appeared in mid-March 2020. In the four years since, a total of 1,745,994 bankruptcy cases have been filed — a decrease of 44.1 percent from the number of filings during the four years immediately prior to the pandemic.


The following charts show recent weekly filing trends by chapter compared to the same week during the last four years.


Week Ending March 17






Total Bankruptcy Cases Filed in Florida Calendar Years 2000 - 2023




Total Filings Relative to Population 2000 - 2023




Bankruptcy Filings per 1,000 Population Florida vs. National Average 2000 - 2023




Chapter 7 Cases Filed In Florida Calendar Years 2000 - 2023




Chapter 11 Cases Filed in Florida 2000 - 2023








Chapter 13 Cases Filed in Florida 2000 - 2023



Percent of Cases Filed as Chapter 13 Calendar Years 2000 - 2023









National Average = 16.8% Increase




