## Weekly Bankruptcy Analysis March 25-31, 2024



The 12,826 bankruptcy cases filed last week represented the highest weekly total in three years. Three factors contributed to the high weekly filings. First, filings have been on the increase for nearly two years, after falling precipitously due to the pandemic. Second, filings are always higher in March and April than at any other time during the year. Finally, filings always spike on the last business day of the month due to the chapter 7 means test.










# Total Bankruptcy Cases Filed in Texas Calendar Years 2000 - 2023















# Chapter 11 Cases Filed in Texas 2000 - 2023






### Percent of Cases Filed as Chapter 13 Calendar Years 2000 - 2023












# Unemployment Rate By Quarter 2006 - 2023






# Bankruptcy Filing Trends Calendar Year 2023 vs. 2022
