Weekly Bankruptcy Analysis March 27-April 2, 2023




The 11,239 bankruptcy cases filed last week represented the highest weekly total in nearly two years. Three factors contributed to the relatively high weekly filing total. First, filings are always higher on the last business day of the month, because of the income calculations used in the chapter 7 means test. Second, filings are higher in March and April than any other months. Finally, filings have been on the increase in recent months after bottoming out in the first half of 2022.



Chapter 11 Cases

The 102 chapter 11 cases filed last week included 36 small business cases, 31 of which elected to proceed under subchapter V. Excluding related cases, filings were only about half as high as filings during the same week in 2019 (pre-pandemic).

There were five large or notable chapter 11 cases filed during the week. Coupon and marketing company PacificCo Inc. filed in the Southern District of New York on March 28 and 29, along with 14 related entities. SiO2 Medical Products, Inc., holder of 245 patents, filed in Delaware on March 29, along with two subsidiaries. Also on March 29, resort developer Banyan Cay Resort and Golf, LLC filed in the Southern District of Florida, along with four related entities. Natural gas energy wholesaler Lincoln Power LLC and seven related entities filed in Delaware on March 31. Finally, online grocery retailer Boxed, Inc. filed in Delaware on April 2, along with four related cases.
