Weekly Bankruptcy Analysis May 22-28, 2023¹

The 8,797 bankruptcy cases filed last week were above the number of filings during the same week in 2022, but below the number of filings in 2020 and 2021. While on the rise from last year, weekly filings are still running well below pre-pandemic levels.







Bankruptcy Filing Trends (All Chapters) Percent Change From 2022, 2021, 2020 and 2019

Chapter 11 Cases

The 123 chapter 11 cases filed during the week were well above the weekly total for the same weeks in 2021 and 2022. However, nearly half of the cases were related filings by corporate subsidiaries. Excluding related cases, filings last week were fairly comparable to filings during the same week each of the past three years.

There were two large or notable chapter 11 cases filed during the week, both of which were filed in the Southern District of Texas. On May 23, health insurance distributor Benefytt Technologies, Inc. filed along with 17 affiliates. On May 24, telecommunications and power contractor Qualtek Services Inc. filed along with 17 related cases. Also of note during the week was the chapter 9 filing by the San Benito Health Care District, which filed in the Northern District of California on May 23.



Large Chapter 11 Cases

I have informally tracked large or notable chapter 11 case filings since the onset of the pandemic in March 2020. To get on my list, a debtor must have at least \$100 million in assets or liabilities at filing or be a case that is of interest beyond a local area. There have been 365 such cases filed since March 2020.

Early in the pandemic (from March through July 2020), an average of 23 large chapter 11 cases were filed per month. Between August 2020 and the end of 2022, this number dropped to about six large cases per month. Large case filings have picked up so far in 2023, with 63 large cases filed during the first five months of the year (with a few days to go).
