
The 8,616 bankruptcy cases filed last week were above the number of filings during the same week in 2021 and 2022, but slightly below the number of filings in 2020. While on the rise from last year, weekly filings are still running well below pre-pandemic levels.



Chapter 11 Cases

The 226 chapter 11 cases filed during the week were well above the weekly total for the same weeks the last four years. However, most of the cases were related filings by corporate subsidiaries. Excluding related cases, filings last week were fairly comparable to filings during the same week each of the past three years.
