


The 11,768 bankruptcy cases filed last week represented the highest weekly total for filings in more than two years, although bankruptcy filings remain well below pre-pandemic levels.

Chapter 11 Cases

The 171 total chapter 11 cases filed during the week were more than double the number filed during the same week the last two years. Excluding "child" cases, the number of filings was considerably higher than filings during the same week each of the last three years.

There were four large or notable chapter 11 filings during the week. The filing by the Archdiocese of Baltimore was the 36th chapter 11 case filed due to clergy abuse. This includes eight archdioceses, 25 dioceses and three religious orders. (An archdiocese is generally larger than a diocese and is headed by an archbishop.)
